It is official: The end of maintenance for SAP Identity Management (IdM) has been announced for 2027. Extended maintenance is available for a fee until the end of 2030, but there will be no direct successor from SAP. It is high time to act because migrating to another tool requires some preparation.

It is clear that there will be no successor to SAP Identity Management (IdM). At the end of maintenance in 2027, SAP will end mainstream maintenance of the software solution and retire it for good. The strategic partnership with Microsoft in the area of identity management, which SAP officially announced at the DSAG Technology Days 2024, offers new opportunities, but also raises a number of new questions.

A situation that requires SAP IdM customers to carefully plan and prepare their future IAM landscape to ensure that their company can continue to operate smoothly after 2027 – without security risks and by taking into account all compliance requirements. In this context, the question also arises as to how long the old IdM system should continue to be used, how long parallel operation is necessary and what is the best economic time to switch to a new system. A change that also offers the opportunity to rethink the topic of Identity & Access Management in the company and to become aware of roles, tasks and significance in the company.
